
(SYRPA) and State Park Volunteers

There are often questions about the different roles of SYRPA Members and the role of State Park Volunteers, Volunteers and nonprofit organizations are an integral part of the California State Parks experience. Most State Parks have a Volunteers in Parks Program (VIPP) and also benefit from the support of a Cooperating Association, such as SYRPA. State Park volunteers act under the direction and control of State Park staff. State Park volunteers support Park staff in administration, interpretation, Park operations and facilities/grounds maintenance. Volunteers who are trained to provide interpretive services are often referred to as Docents. All Docents are volunteers, but not all volunteers are Docents. Docents go through specific training in a particular Park function such as Gold Panning, Barn Tours, Wildflower walk leaders, etc.

From a visitor's perspective, whether services are delivered by State Park staff, State Park volunteers and Docents or SYRPA members is unimportant. What is important is that services are delivered in a professional manner and enhance the visitor's experience to our Parks.



Over the years, major projects of SYRPA have included:


- Working with California State Parks to restore and preserve the wooden covered bridge
- Restoration of the Shell gas station
- Obtaining expansion of the Historic Area Designation to include the ranch area, the turnpike and the cemetery
- Working with California State Parks to maintain and improve the Independence Trail
- Restoration of a number of the historic wagons housed in the historic Barn

SYRPA is an entirely volunteer-run organization with a Board of Directors that oversees the association's finances and activities including special fundraising events that provide funds to cover expenses for various interpretive and educational activities in the parks including school tours, wildflower walks, bird walks, geology walks, gold panning demonstrations, and interpretative tours. The expenses funded by SYRPA include purchasing gold for gold panning in the parks and at the Nevada County Fair, purchasing merchandise for the Visitor Center and upgrading the signage in the park.

Other initiatives include:

- Repair and maintenance of the historic Barn
- Maintenance and restoration of portions of the Independence Trail
- Improve Visitor Services, including upgrading the displays in our Visitors Center.
